24-25 School Year End of Year Recap June 6, 2025

We hope you had a fantastic year! The second half of the school year was full of exciting developments that we wanted to highlight. Below, you'll find key updates along with links for more details.

#### **Feature Updates**

- **Call-In Surveys:** In order to help us continue delivering exceptional support, we started sending short, optional follow-up surveys to users after they call the Help Desk. Learn more.
- **Version/Document History:** Version History now tracks document share events, permission changes, guardian share email status, and document views. Learn more. Additionally, we renamed Version History to Document History. Learn more.
- **Bulk Load Absences:** Student absences can now be bulk loaded by admin users. Once absences are loaded, they are stored on the student's Details tab. Learn more.
- **Single-Line Default Banks:** Admin users can now save single-line district banks as default text. Learn more.
- **Asynchronous Bulk Printing:** When bulk printing documents, users can navigate away from the print preview page while the preview generates. Learn more.
- **Guardian Share:** When sharing documents with a parent/guardian, if the guardian email is stored in SameGoal, users will be able to select the guardian from a dropdown list and their name and email will populate the fields automatically. Learn more.
- **Permission Requests:** Users can now request access to documents, including requesting a transfer of ownership. Additionally, document owners will still be able to transfer document ownership after they've lost access to the document (such as when a student moves to a different building). Learn more.
- **Caseload Filter:** There is a new filter on the Students / Create New page that will filter the list to only show students who have at least one document on the user's

Caseload. Learn more.

• **Suggested Accounts:** If a user works in multiple districts, they can choose to have SameGoal remember their accounts. When logging in or adding a linked account, SameGoal will suggest saved accounts. Learn more.

## **Special Education Updates**

- **Full and Individual Evaluation Signatures Report:** This new report returns a list of everyone who signed the FIE. Learn more.
- **Updates to the Next School Year Section of the IEP:** This section of the IEP was updated to more closely align with the Placement of Services section. Learn more.
- **SPPI 13: Eligible Students Report:** This new report returns a list of Special Education students aged 16-21. Learn more.
- **Missing Progress Report for Stub IEPs Report:** This new report returns a list of stub IEPs that do not have a corresponding IEP Progress Report. Learn more.
- **TELPAS Assessment Report:** There are two new reports that return TELPAS information from section 9 of the IEP. Learn more.

## **Section 504 Updates**

- **504 General Education Homebound Report:** This new report returns a list of students receiving homebound services. Learn more.
- **TELPAS Assessment Report:** There are two new reports that return TELPAS information from section 3 of the 504 Plan. Learn more.
- Excusals from Graduation Requirements for EOC Assessments Report: This new report returns a list of students excused from graduation requirements. Learn more.

#### **Emergent Bilingual Updates**

- **Parental Denial Forms:** Both Parental Denial forms were revised in alignment with the TEA's recent changes. Learn more.
- **LPAC Monitoring Year Report:** This new report returns a list of reclassified students and indicates which year of monitoring they are in. Learn more.
- **Emergent Bilingual Sub-Programs:** The Emergent Bilingual Program was split into three sub-programs: Emergent Bilingual, Reclassification Monitoring, and Dual Language. Learn more.
- **Split Out Deadline Reports:** The Emergent Bilingual Deadlines report was split into three separate Deadlines reports. Learn more.
- **Student History Worksheet:** This new form can help track a student's historical information for TELPAS reporting. Learn more.

#### **Gifted/Talented Updates**

- **Bulk Load NWEA MAP Scores:** MAP scores can be bulk loaded for students. This information can then auto-populate the G/T Student Identification Profile. Learn more.
- **TEKS Banks:** TEKS information is now stored as bank values in the Goals/Learning Opportunities section of the G/T Education Plan. Learn more.
- **Gifted/Talented Referral Report:** This new report returns basic referral and consent information. Learn more.
- **Parent/Teacher Surveys:** Parent/teacher input can now be documented in standalone forms or in the G/T Consent for Assessment form and the Gifted/Talented Services Referral Form. Learn more.
- **Bulk Load CogAT Scores:** CogAT scores can be bulk loaded for students. This information can then auto-populate the G/T Student Identification Profile. Learn more.
- **SIGS Support:** Support has been added to store SIGS ratings on a student's Details tab and for SIGS scores to be bulk loaded. This information can then auto-populate the G/T Student Identification Profile. Learn more.

## **General Form and Report Updates**

- **Dyslexia Screening Exemption Reason Report:** This new report returns exemption information for Special Education and Section 504 students. Learn more.
- Admin-Only Deadlines Report: This new report returns deadline information for all special programs. Learn more.
- **TestHound Report Is Amendment-Aware:** The TestHound report is our first amendment-aware report, meaning information will still pull from documents that are temporarily marked incomplete due to an amendment. Learn more.
