

## Program Deadlines - Special Education

Special Programs deadline tracking calculates upcoming document deadlines directly from existing documents as they are completed.

When a deadline is the sooner of a calculation stemming from more than one document, the deadline is marked "provisional". This deadline may change on the information in the remaining related documents. Once all documents used in a given deadline calculation are completed, the deadline is no longer provisional.

Most deadlines are based on state and federal law. However, several (particularly deadlines for prior written notices) reflect best practices.
